

APPLICATION FOR PRODUCT AUTHORISATION FOR USE IN SOUTH EAST WATER'S WATER AND SEWER NETWORK

PRODUCT APPLICATION CRITERIA

South East Water (SEW) will only appraise a new product if it meets one of the following conditions:

- The product has received a positive appraisal from the Water Services Association of Australia (WSAA).
- It fulfils a gap or specific need that no existing approved product can effectively perform.
- The product is required to be used in a SEW Capital Works project, subject to a positive preliminary assessment.
- A specific request from a peak industry body such as the Civil Contractors Federation (CCF) and Association of Land Development Engineers (ALDE).

In addition to items (b), (c) and (d), the SEW product team will assess whether it is more appropriate for the product application to be referred to WSAA for an independent appraisal. New Product applications received without a positive WSAA appraisal will require a SEW invitation before an application for product authorisation will be considered.

IMPORTANT NOTE:

Where there has been a WSAA appraisal published and it is still current, only the Applicant and Distributor details shown on the following page needs to be completed, unless otherwise requested.

Otherwise the applicant must fully complete this form and append all appropriate certificates and test reports as required for verification and any other product information that may assist in understanding the product. Incomplete forms may be returned for completion without processing.

The applicant must complete a separate application form for:

- Multiple products requiring appraisal that are manufactured to different national and international standards, nationally recognised water industry standards and specifications.
- Products acquiring appraisal from different manufacturers.
